Statistical Year Summary of Transfer of Cases Under 28 U.S.C. § 1407



During Fiscal Year 2020 (October 1, 2019-September 30, 2020), 231,495 civil actions were subjected to coordinated or consolidated proceedings established by the United States Judicial Panel on Multidistrict Litigation, pursuant to 28 U.S.C. § 1407.

The Panel transferred 4,210 cases that were pending in 90 district courts to 31 transferee districts for inclusion in a multidistrict litigation docket. Another 227,285 actions were filed directly in transferee districts. This represent a significant increase from the previous twelve-month period, due to an influx of more than 200,000 cases directly filed in the Northern District of Florida in MDL No. 2885 - 3M Combat Arms Earplug Products Liability Litigation. Most of these cases were filed in an administrative docket established by the transferee court to facilitate an efficient process for the parties to obtain confidential information from the Department of Defense and the Department of Veterans Affairs.

Fifty-four motions to centralize were filed in Fiscal Year 2020. Fifty motions to centralize were either acted on or disposed of between October 1, 2019 through September 30, 2020. The Panel granted 21 of those motions, creating new multidistrict litigation dockets in the following categories: products liability (6); antitrust (4); intellectual property (3); “miscellaneous” litigations (5, one of which involved customer data security breach); marketing and sales practices (1), securities (1), and employment practices (1).

The Panel denied 20 motions, declining to transfer 111 cases. Eight of the motions to centralize were withdrawn by the movants and one was deemed moot due to no longer having multidistrict character.

Since the creation of the Panel in 1968, there have been 953,641 civil actions centralized for pretrial proceedings. As of September 30, 2020, a total of 17,104 actions had been remanded for trial and 609,333 actions had been terminated in the transferee court. At the end of this statistical year, there were 327,204 actions pending in 176 MDLs in 44 transferee district courts.
